Event Terms & Conditions

These terms and conditions govern your participation in any APPWS online (virtual) event; meeting; webinar; summit; convention, congress; or conference ('the Event'). This event is managed by host organisations (referred to a 'APPWS') Prader-Willi Syndrome Australia and Prader-Willi Research Foundation Australia and done so in conjunction with Prader-Willi Syndrome Association NZ, Prader-Willi Syndrome Malaysia and Prader-Willi Syndrome Association Thailand. gener8 Events is acting as an agent on the host organisations behalf for the purpose of taking registrations and collecting and administrating all event payments. All monies are disbursed back to the host organisations (less an administration fee) for the purpose of APPWS managing the event.

By registering for the Event, you agree to these terms. If you are registering on behalf of another individual, it is your responsibility to ensure the person participating is aware of these terms and accepts them. By completing the registration on behalf of another individual you are warranting that you have made the participant aware of these terms and that they have accepted these terms.

1. Pricing:

1.1 All prices are in Australian dollars and include 10% GST.

2. Registrations:

2.1 Please refer to your selected registration packages for inclusions.

2.2 Special dietaries and any other special needs will be catered for when advised in advance at the time of registering.

3. Accommodation:

3.1 Accommodation is not included in your registration package.

4. Travel:

4.1 All costs and arrangements associated with your travel to and from the conference are at your own cost and arrangement.

4.2 Flights, ground transportation, public transport and parking if required are at your own cost.

4.3 It is recommended that you take out travel insurance to cover any unforeseen circumstances that might impede your ability to travel.

5. Payment Terms:

5.1 Payment of the conference registration fees is to be made direct to gener8 events acting as an agent on behalf of APPWS.

5.2 Full payment for the conference must be paid when booking and is charged in AUD (Australian currency) and includes 10% GST (Goods & Service Tax)

5.3 Payment mustbe made by credit card. All credit card payments attract credit card surcharges as follows: Visa, Mastercard, JCB, Discover & Amex = 1.86%

5.5 Please note these credit card charges are directly passed on by gener8 at the rates charged to them. They are higher than standard retail outlet rates as they are charged as online merchant rates.

5.6 A taxation invoice/receipt will accompany your registration confirmation which will be emailed to you once your registration is processed.

5.8 If you book in for the Early Bird pricing, if full payment is not received on or before Early Bird pricing ends, your registration will default to full price.

6. Cancellation Terms:

6.1 Your registration is fully refundable (less a \$50 handling fee per person and any credit surcharges paid) if cancellation is received and acknowledged in writing by emailing registrations@gener8.com.au by 30th July 2024.

6.2 After this time cancellations are non-refundable, however they can be transferred to another person, else forfeited.

6.3 Refund requests for special circumstances within the 30 days before the Event, may be applied for in writing to <u>registrations@gener8.com.au</u> and will be considered by the APPWS organising committee on a case by case basis.

Special Covid clause: Outside of these dates, If a positive Covid-19 diagnosis, or imposed government restriction or mandate stops you from personally attending the Event then we request you advise us of this as soon as you are aware. You will be encouraged to send a replacement and your ticket is fully transferrable for this purpose (at no penalty). If however you are unable to send a replacement, a refund may be possible. Please note possible refunds on any conference amounts will depend on how much notice is provided ahead of the event commencing, and where substantial non recoupable penalty costs are not incurred by APPWS a proportioned refund may be offered. Please note the \$50 admin fee per person will still be applicable to any refunds issued. Please note official proof of diagnosis may be requested by APPWS prior to any refunds being approved. Please be sure to contact gener8 events directly immediately upon knowledge or your inability to attend and we will work with you to assist with this process to the best of our ability.

7. Non Discloser:

7.1 gener8 and APPWS will only use personal information provided for the purpose of managing your participation in the Event

7.2 Images (Photo and Video) collected during the course of the Conference by APPWS and gener8 Events may be used by APPWS and its representative for future marketing activities.

9. Conference Cancellation or Postponement:

9.1 gener8 Events and APPWS do not accept any liability for losses incurred if the Event is cancelled or postponed due to an unforeseen occurrence or any other occurrence that renders performance of this event inadvisable, illegal, impracticable or impossible.

An unforeseen occurrence shall include but shall not be limited to: an Act of God; infectious disease outbreak, industrial disruptions, service provider failures, governmental restrictions and/or regulations; war or apparent act of war; terrorism or apparent act of terrorism; disaster; civil disorder, disturbance, and/or riots; curtailment, suspension, and/or restriction on transportation; or any other emergency.

9.2 If the Event is cancelled due to a force majeure occurrence before the first day of the event, then gener8 Events and APPWS will reschedule the affected event and your registration fee will be applied to the rescheduled event - where related event costs have not already been incurred (eg. Food ordered or prepared etc.)

9.3 Where a technical outage/malfunction is the cause for a temporary or complete failure to broadcast the event and it cannot proceed, the event may be rescheduled to an alternative date or content will be made available to view online at your leisure (on-demand). gener8 Events will make every effort to communicate with registrants regarding the technical outage/malfunction via the online portal or if the platform is unable to transmit communication, an alert will be sent via email, conference app or mobile text message, and posted to the Event website.

10. Limitation of Liability:

10.1 gener8 Events and APPWS does not take responsibility for technical issues outside of their control, i.e. internet and power outages. Where possible gener8 Events and APPWS will supply backup solutions to avoid any prolonged interruptions, but this cannot be guaranteed if the cause of the interruption falls outside their jurisdiction.

10.2 APPWS or gener8 Events will not in any event be liable for special or consequential damages, including without limitation extra expenses, loss of profits, or damages

consequential upon loss of use, whether arising from either party's negligence, and even if the possibility of such damages is or was foreseeable by either party.
